PROFESSIONAL SERVICES

Thank you for selecting Roselawn Memorial Park for your permanent memorialization needs.

So that the charge for our professional services may be recognized as fair and in keeping with the operations of an economical and efficient cemetery, we have listed below the many operations involved in performing our professional obligation.

- ❖ Discuss the arrangements for burial with funeral director or family.
- **Examine** the record of lot owner to determine ownership.
- Check permanent files for any special instructions issued by lot owner or affidavits affecting the burial.
- ❖ Make appropriate phone calls.
- ❖ Prepare interment order authorizing burial.
- Prepare interment card for your loved one and entry made on the record of lot owner (duplicate records are made for safety).
- * Record interment on lot card.
- ❖ Prepare instructions to Foreman for grave opening operation.
- * Foreman must lay out exact location of grave; this will be verified by second associate to avoid chance of error.
- Deliver necessary equipment to gravesite (canvas and boards to protect surrounding areas; hand tools, power equipment, etc.)
- ***** Excavate interment space by machine, or hand, if necessary.
- Remove dirt, dump, and level dirt.
- * Remove all digging equipment.
- Set up lowering device.
- ❖ Attendants to assist in carrying and arranging flowers, when necessary.
- ❖ Associates will help close vaults after ceremony, help remove lowering device, fill in grave, seed and assist in rearranging flowers.
- Supervisor supervises and checks entire site.
- Remove excess dirt and clean up gravesite.
- * Remove flowers when wilted.
- * Refill grave when natural settling of the earth takes place.
- ❖ Maintain cemetery equipment. Much equipment is required to perform these services properly.
- * Render any extra service that may be needed or requested. A good cemetery is a service institution, first and foremost.
- Adaintain an appropriate office and grounds maintenance staff, so that a qualified person is available during business hours, 5 days a week, to assist in making cemetery and funeral arrangements. Saturdays by appointment.

When arranging for a burial or inurnment, there can be no failure in service; no breakdown in equipment, no shortage in labor. No matter how severe or disagreeable the weather may be—during the extreme heat of the summer or the bitter cold of winter, this work must go on. In most areas of the country, state or local law does not require that you buy a container to surround the casket in the grave. However, Roselawn Memorial Park requires that you have such a container, to protect the physical integrity of the grave and for the safety of our staff and visitors. Either a grave liner or a burial vault will satisfy these requirements. Roselawn does require an urn and vault for Ground Cremation Inurnment.
